General

- You must observe Ardagh's safety, hygiene and environ mental regulations while you are on our company premises.
- You are on our company premises entirely at your own risk; Ardagh accepts no liability whatsoever in the event of damages or loss.
- Everyone is required to report in. Please report to the gatehouse and then at the loading/unloading bay, following the route that is marked on the map (inside).
- If you are unsure or if anything is unclear, ask the loading/unloading bay staff to explain.

Loading and unloading

- The cargo area or container must be clean and dry and must not smell.
 - The canvas must be fully watertight. The **driver** is required to make a **visual** inspection of the **cargo area/container** and **the products to be loaded** at Ardagh before loading the products.
- Ardagh reserves the right to verify the inspection made by the driver.
- Containers are sealed. Seals are provided.
- Always check and sign your transport documents and get them signed off by an authorized member of Ardagh's staff before you leave.



Key INSTRUCTIONS and WARNINGS
